Womack explained the IPMC is used by the Building Inspector and City Manager. Part of the code is that all properties are required to have address visible from the street side of the property. Womack has drafted a policy – please have all comments to City Manager before next council meeting. The address is ok if it is on the mailbox or post at end of driveway if building is not visible from Road.

Hopkins explained this application is only covering what the Chamber of Commerce is doing. It is similar to last years event "Christmas in July"

 - a. Vendors Ordinance Example

Womack explained that Mr. Rowland has permission from MCU Body Shop to sell hot dogs from his Hot Dog Cart Portable Business on private property. Womack said we might get complaints from brick & mortar businesses that pay property taxes; food trucks and portable food vendors do not pay property taxes. There are pros and cons to allowing portable food vendors and food trucks in the city. Our current zoning code does not allow these types of businesses.

Mr. Rowland explained this is his business and how he makes money to support his family. He sells Polish Dogs, Chilly Cheese dogs, pop and chips. He would like to sell in other locations of the city as well.

City Council would like Womack to develop a policy to allow this activity.
