



FENCE ZONING PERMIT APPLICATION

No fence shall be erected without first receiving an approved fence permit from the City. The zoning administrator shall approve the placement of a fence and may require a land survey be submitted and/or the land be staked prior to approval. Fences that are erected without a fence permit are subject to municipal fines and removal in whole or in part.

Applicants are asked to complete the Fence Zoning Permit Application in its entirety and forward it to the Zoning Administrator as part of the permitting process. Once this Fence Zoning Permit Application and supporting materials are determined to be complete, the City will act on the application.

The fees associated with a Fence Zoning Permit Application are \$ 5.00 (five dollars).

FENCE ZONING PERMIT APPLICATION INFORMATION

1. The City's fence ordinance is found at Sec. 40-446. - Walls and fences. (NEW-Sec. 32-535) Proposed fences shall be reviewed and considered for approval based upon the rules and requirements found in the fence ordinance. The ordinance can be found under FORMS on the City's website.
2. Applications for zoning approval which propose fences or walls on or near property lines may be required to submit a land survey and/or stake the land prior to approval.
3. Fences shall be installed in a workmanlike manner and be maintained at all times in a state of good repair
4. Fencing material shall be all weather, high-quality, low maintenance and must be made of composite, chain-link, metal, wood, vinyl, brick, stone or other material approved of by the Planning Commission. All fencing material shall be specifically designed to be used for fencing and shall not be constructed of junk, scrap, salvage or other materials not designed for use as a fence.
5. Fence height:
 - a. Solid/Opaque/Privacy fences may not exceed three (3) foot tall within a front yard.
 - b. Solid/Opaque/Privacy fences may not exceed six (6) foot tall within the secondary front yard of a corner lot.
 - c. Chainlink/wrought iron/picket fences/see-thru fences may not exceed four (4) foot tall within the front yard.
 - d. Solid/Opaque/Privacy fences may not exceed a height of six (6) feet behind the front building line of principal structures in residential districts.
6. Fences with a decorative side shall be erected with that decorative side facing the adjoining street or abutting property owner's premises.
7. It shall be unlawful to construct any fence in any public right-of-way or across a utilities easement. Any fence constructed in any public right-of-way or across a utilities easement may be removed as a nuisance.
8. No fence shall be erected or maintained on any lot or parcel that will, in the opinion of the zoning administrator, obstruct vision of the road intersection or of a sidewalk.
9. It is strongly advised for applicant to submit a spec sheet or cut sheet of the proposed fence which illustrates what the final fencing will look like along with this application.

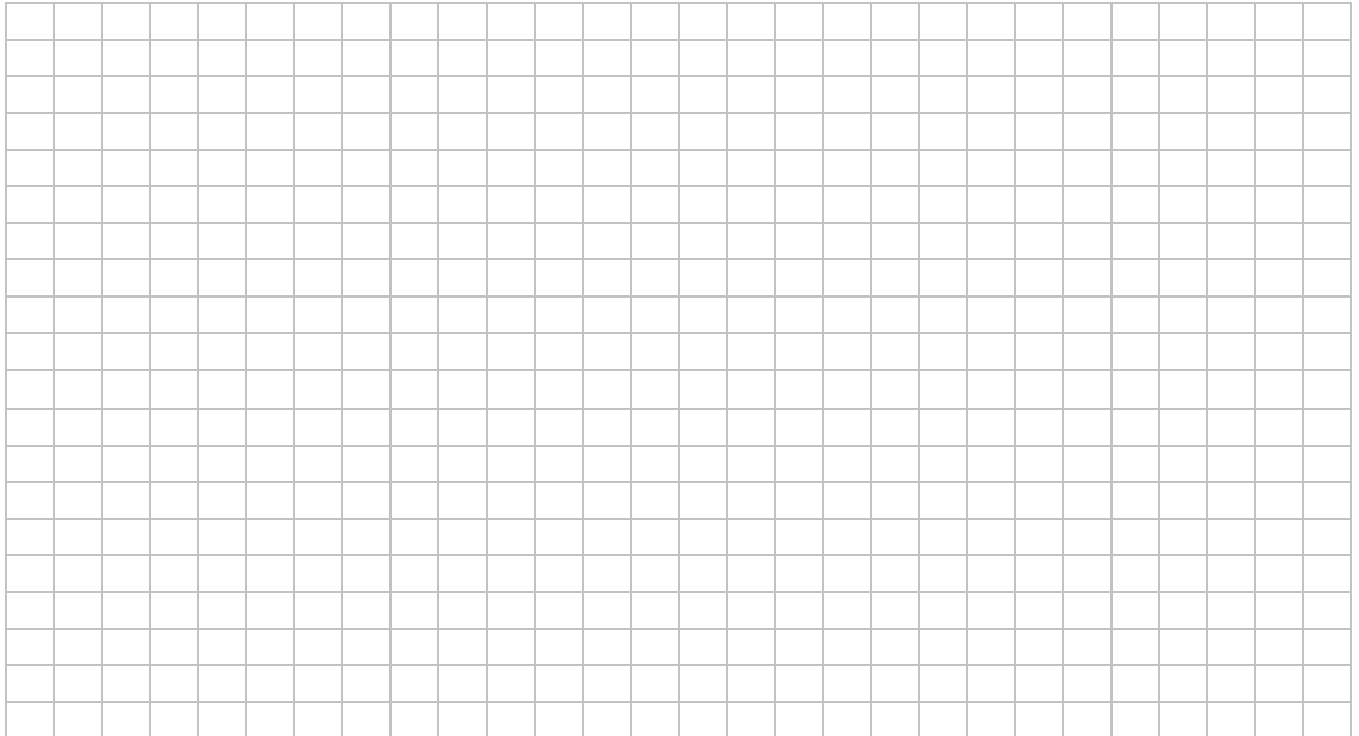
City of Cedar Springs Zoning Permit - Property Sketch
